

→ What to do when a Child Reports Abuse

When a child reports possible abuse:

Do:

- Prepare - a child may disclose abuse whenever you are around children
- Give the child your undivided attention
- Consider how your body language, facial expression and words may effect the child
- Consider the child's safety - e.g. can the child go home today?
- Consider the child's privacy
- Document the child's exact words
- Reassure the child about telling
- Reassure the child that s/he is not in trouble with you
- Respect the child and her/his disclosure
- Call 911 immediately

Do Not:

- React with panic or other strong emotions
- Try to conduct your own investigation or try to validate the child's report
- Ask detail seeking questions
- Use interview tools such as dolls or diagrams to learn more
- Ask the child to repeat his or her statement for others
- Share the information with those who don't need to know
- Confront or challenge the child
- Try to reframe what the child has told you
- Lie or make promises about what will happen next

CornerHouse Goes to Japan

Expanding Our Reach: CornerHouse in Japan

Through continued collaboration with child welfare professionals throughout Japan, CornerHouse trainers will make multiple trips to Japan during 2010.

CornerHouse is excited to build on the successes of our previous work in Japan by bringing additional training sessions to various regions of the country.

CornerHouse regularly provides trainings, in a variety of locations, as a part of its commitment to realize its vision of ending child abuse. Of course, that goal can't be met by any one organization. Our strategy is to expand best practice in forensic interviewing wherever possible so that the child welfare community can work together to achieve the vision.

In January, CornerHouse Interviewer/Trainer, Julie Stauffer, spent more than a week teaching Japanese professionals how to talk to children about concerns regarding suspected maltreatment. With the help of Japanese-English interpreters, Julie explained the CornerHouse pre-assessment protocol for talking with children prior to an investigative interview. Participants learned about the dynamics and disclosure process of sexual abuse as well. This one-day course was offered in the

cities of Miyazaki, Tokyo, Hiroshima and Nagoya. Nearly 400 professionals were trained including attorneys, social workers, physicians and educators.

Julie looks forward to returning to Japan in June. During this trip, pre-assessment protocol training will be offered in the cities of Sendai and Nagaoka along with a four-day Forensic Interview training in Tokyo. In Tokyo, Julie will teach 40 child abuse investigators a credible, reliable and non-traumatic forensic interview process for children who allege sexual abuse. Participants will learn the CornerHouse Forensic Interview Protocol, RATAAC[®] as well as child development, the use of anatomical dolls and blocks and problems in interviewing.

Another exciting development in Japan is the advent of the ChildFirst train-the-trainer program. Through the continued partnership with the National Child Protection Training Center (NCPTC), CornerHouse staff will teach Japanese faculty how to become effective trainers of the RATAAC[®] interview protocol in their local communities. Throughout the United States, ChildFirst has dramatically expanded the reach of the CornerHouse training program by making high quality forensic interview training available in local communities. We are honored to bring this same kind of resource to Japan.

→ New and Improved Video-Recording System at CornerHouse

New Technology Comes to CornerHouse

Thanks to a grant from the Minnesota Department of Human Services, CornerHouse has just completed the installation of an upgrade to our video-recording system. This system is used in the recording of forensic interviews conducted at CornerHouse. Previously, recordings were made to DVD and DVCam; the new system will record to DVD and will also begin recording directly to a server through an Internet based system called VideOversight.



The new system from Microception, updates older equipment, reduces the cost of each interview by 15.00 per interview and offers our partner agencies in law enforcement and child protection access to the interviews through a protected Internet connection. This access, which is password protected and secured off site in a

designated server will make it possible for child protection and law enforcements officers who for some reason cannot attend the actual interview to view it over a secure setting.

For non-profits, it can be difficult to maintain changes in technology. This update will help CornerHouse to assure that we are meeting the needs of our clients by streamlining the interview process so that the technology is reliable, flexible and less expensive.

→ Training Opportunities

CornerHouse Interagency Child Abuse Evaluation and Training Center is committed to expanding the education and awareness of sexual abuse through its training programs. The following courses are coming up:

Child Sexual Abuse Forensic Interview Training

This training teaches a credible, reliable and non-traumatic forensic interview process for children and vulnerable adults who allege sexual abuse. Training methods include lecture and discussion, review of CornerHouse videotaped interviews, skill-building exercises and an interview practicum. The course is designed for teams of law enforcement and child protection investigators, prosecutors and forensic interviewers. Participants are strongly encouraged to attend as a multi-disciplinary team. Courses are outcome based and include an exam upon completion. **Course Fee: \$950**

Advanced Forensic Interview Training

This training is open to law enforcement and child protection investigators, prosecutors, and forensic interviewers who have completed the required prerequisites. This course teaches advanced forensic interviewing issues, modifies the interview protocol for physical abuse and other violent crimes, outlines research on memory and suggestibility, provides a mock cross-examination demonstration, and provides participants the opportunity to learn and utilize a video-recorded interview assessment tool to critique their own interviews. **Course Fee: \$850**

Prerequisites

Completion of one of the following basic interviewing courses:

- CornerHouse Child Sexual Abuse Forensic Interview Training or On-Site training
- *First Witness*™ Forensic Interview Training
- *ChildFirst*™: Forensic Interviewing and Preparing for Court
- *Finding Words*™ Forensic Interview Training (that teaches RATAAC®)

Completion of a minimum of fifteen (15) interviews using RATAAC® (waived for prosecutors)
